
1. The Contractor/ Firm/Private Limited Company registered with Assam PWD Building, as detailed in the table above having experience of similar nature of works are eligible to participant in the bid. Up to date Registration Certificate, Registration Certificate under GST, PAN, EPF, cost of bid etc. as required shall be furnished along with the application seeking issue of Bidding Document.
2. Bidding Documents may be purchased in office hours from the O/o the Principal, B. Borooah College, Guwahati on payment of a non-refundable fee as stated in the table above in the form of Bank Draft/Banker's Cheque on any Nationalized/Schedule Bank payable at Guwahati and drawn in favour of the "**Principal, B. Borooah College**". Interested bidders may obtain further information from the office of the undersigned.
3. Bids must be accompanied by Bid security of the amount as specified for the work in the table above in the form of Fixed Deposit Receipt/Bank Guarantee from any Nationalized Bank/Scheduled Bank in prescribed format given in SECTION-8 of the bidding document. Bid Security shall have to valid for 45 days beyond the validity of the bid. Bids without requisite Bid security shall be summarily rejected.
4. The bid security shall be pledged in favour of the **Principal, B. Borooah College**, Guwahati in one of the following forms:
 - a) Bank Guarantee from Nationalized Bank/Scheduled Indian Bank in favour of **Principal, B. Borooah College**. (A written confirmation in the Bank's letter head confirming the authenticity of the Guarantee shall be furnished along with the Guarantee).
 - b) Fixed Deposit Receipt issued by any Nationalized Bank/Scheduled Indian Bank or a foreign Bank approved by R.B.I., acceptable to the employer.
